**Subject:-** <sup>1st</sup> Grant of 3<sup>rd</sup> MACP Scheme to Sr. Auditors/Clerks/MTS.

The Competent Authority has approved the grant of <sup>1st</sup> 3<sup>rd</sup> financial up-gradation from the date and with Grade Pay as shown against them as per Annexure A attached.

2. Their placement in the higher scale of pay/grant of one financial up-gradation will be subject to the following conditions:-

- (i) They are actually borne on the strength of the organization as on date on which the MACP benefit is being given.
- (ii) The placement in the higher scale of pay/grant of one financial up-gradation under MACP scheme is only on personal basis and shall therefore neither amount to financial/regular promotion nor to change in existing designation or seniority position.
- (iii) The pay shall be fixed under the provision of FR 22(1)(a)(1). The financial benefit allowed shall be final and no pay fixation benefit would accrue at the time of regular promotion in the hierarchy in the cadre when given to them on their turn.
- (iv) Grant of higher pay under MACP scheme shall be conditional to the fact that while accepting the said benefit, they shall be deemed to have given their unqualified acceptance for regular promotion on occurrence of vacancies subsequently. In case they refuse to accept the higher position on regular promotion subsequently, they will be subject to normal debarment for regular promotion as prescribed in DOPTs Letter No. 35034/3/2008-Estt (D) dated 19.05.2009.
